Setup:	Friday July 31st : any time after noon
	Saturday August 1st : before 8:30 am - no cars allowed in fair area after 8:30 am
Hours of Operation:	Friday July 31st : your welcome to sell once set up
	Saturday August 1st : 9:00 am – 7:00 pm
	Sunday August 2nd : 9 am to 5 pm

Rules and Regulations

1. **Early Bird Special:** Send in application and payment before June 1, 2020 (postmarked) and pay only \$100.00 for the entire weekend.
2. Send in application and payment on or after June 1, 2020 and pay \$130.00 for the entire weekend.
3. Each vendor must check in with the Vendor Manager. Once it is confirmed that you have paid you will be shown where to set up.
4. The Fair Board has the right to decline any exhibit, display, or activity that is not suitable.
5. Due to changes in grounds configuration, we will not guarantee any location, for any vendor.
6. No raffles or drawings are allowed, unless preapproved by the Fair Board.
7. No vendor's activities may interfere with the display or activities of any other vendor.
8. Vendors to supply their own tent, tables and chairs.
9. **VENDORS MAY NOT SELL ANY OF THE FOLLOWING ITEMS: GUNS, KNIVES, SWORDS, WEAPONS OF ANY KIND, DRUG PARAPHERNALIA, SILLY STRING, SMOKE/STINK BOMBS, LASER POINTERS, FIRECRACKERS, OR SNAP CAPS OF ANY KIND.**
10. Every vendor space shall be kept clean and free of trash. Every vendor is responsible for disposing of their trash in the provided receptacles / dumpster.
11. \$35 service fee will be charged for any returned/bounced checks. Funds owed and the \$35 service fee will then be due in cash.
12. If you need to cancel, we will gladly send you a donation receipt for your donation to the fair.
